Shipping is available in some cases. Client is responsible for all costs associated with shipping or transport. Fees include, but not limited to cost of transport, all health documents required by transport, including additional required vaccinations (rabies), crate or containment as required by transportation. Shipping is done for client at client request. Client has the option to come to Legacy Labs to pick up puppy at no additional charged fees. All shipping/fees are in addition to the cost of the puppy/dog.

All deposits to "reserve" a puppy are non-refundable.

We care about the health and well being of each puppy. We have a veterinary examination on all puppies (except those who will be notified in writing). This exam happens between 7 to 9 weeks of age. It is a detailed full examination at no additional charge to the purchaser. If your puppy comes with a written examination, you are then agreeing to accept the results of this exam as accurate, and you do not need to take your puppy for another initial vet exam. The "BUYER" agrees to accept our veterinary reports as a true statement of health to the "BUYER's" said puppy.

Vaccination Records and Health Exam – will be provided at time of delivery of puppy to "BUYER". "SELLER" (Legacy Labs) will not pay for any vet bills incurred from any vet exam made by the "BUYER"

Spay & Neuter Agreement: All puppies sold as pets must be spay or neutered by 7 months of age. Verification of puppy's spay or neuter must be sent to Legacy-Labs within 30 days of the operation.

Puppies are started on a worming program at two weeks. We wean the pups around four to five weeks depending on their general health condition. We have your pup on nutritious solid dry puppy food and will inform you which brand we are using and urge you to continue with it or mix the brand that you prefer with the one we are using for at least five or six days to minimize digestive problems.

In the event "BUYER" must return the puppy to Legacy Labs, the following conditions must be fulfilled:

1. Puppy must be returned in good health and with all paperwork to our physical address in Terrell, Texas
2. We must approve in writing the day and time of the puppy's arrival
3. No refund will be given
4. Legacy Labs or agents will not pay any expenses related to the return of the puppy
5. Veterinary letter must be sent in writing prior to the puppy's return stating what life threatening defect is in the said puppy
6. A release form provided by Legacy-Labs must be signed and returned to Legacy-Labs prior to puppy/dog arrival

AKC Registration is for Labrador Retrievers only. The Labrador retriever you are purchasing can be registered with AKC (American Kennel Club). What the American Kennel Club Registration means is only that AKC maintains information regarding the parentage and identity of this puppy. It does not guarantee the quality of health of this puppy, and it does not guarantee quality lineage. Since dog pedigree registries depend in large part on the honesty and accuracy of persons registering dogs, registration does not guarantee the accuracy of the lineage.

*Upon written request, within 30 days of sale, the "BUYER" may request AKC registration papers, any request made after the 30 day period will not be granted

Labradoodles are hybrids and therefore are not eligible for AKC registration

We are NOT liable for any genetic testing or DNA results.

Social Media Clause

At Legacy Labs we strive to make all of our puppy "BUYERS" happy and content with matters pertaining to the new puppy. Please contact us in writing and allow for up to 30 days from first notified to resolve any and all matters before posting to social media. Buyer will allow 30 days resolution prior to posting any negative comments to social media, internet, or any public or private forum or entity.

The Terms of our Hip and Eye Guarantee are as follows:

- For a Hip claim, the dog must have had their hips X-rayed by the age of 1 year to be covered by this Guarantee. All X-rays must be submitted to the OFA (Orthopedic Foundation for Animals) for evaluation by Veterinary Radiologists. Preliminary evaluation is acceptable. Proof of genetic dysplasia from the OFA as well as proof of the animal being spayed or neutered must be presented to Legacy Labradors. BUYER accepts responsibility for not overfeeding the dog (which can also bring about hip dysplasia). OFA rating must be "poor".
- For a "Progressive Retinal Atrophy" claim, a licensed Veterinary Ophthalmologist must examine and diagnose the dog by the age of 1 year. A report from that Ophthalmologist must state the diagnosis (of Progressive Retinal Atrophy) and certify that this is absolutely inheritable in nature and could not have been caused by any injury or illness. This Veterinary Ophthalmologist's statement as well as proof of the animal being spayed or neutered must be presented to Legacy Labradors.

BUYER accepts responsibility to not jog with puppy on hard surfaces or allow puppy to jump from heights (i.e. from car or pickup) before 1 year of age. As DJD Grade 1 type elbow dysplasia or unilateral elbow dysplasia can be the result of poor nutrition, improper exercise, injury from jumping or rough playing, no warrantee shall apply for this condition.

- This Guarantee is not transferable. To make a claim against this Guarantee, the original owner who bought this dog must still own the dog.

- To make a claim against this Guarantee, the dog must not have sired or whelped a litter, and must be returned to Legacy Labradors with his/her AKC & UKC Paperwork at the **BUYER's** expense.

- In the event of a legitimate claim against this Guarantee, the puppy will be replaced.

- Our financial responsibility will be limited to this original purchase price of the puppy or a replacement puppy (at our option). All veterinary bills accumulated by owners are the financial responsibility of the owner.

No guarantee is made for any condition other than Hip Dysplasia, Progressive Retinal Atrophy (PRA)

We are not liable for any results from Genetic or DNA testing.
